INTRODUCTION

1. BACKGROUND OF SUB RECIPIENT

SOLIDARITY FOR HER EDUCATION AND EMPOWERMENT ORGANISATION(SHEEO NGO)

Solidarity for Her Education and Empowerment Organisation – SHEEO is a grassroots young feminist, non-partisan, non-profit and non-governmental organisation striving to help rural adolescents' girls and young women thrive and become autonomous in rural Tanzania.

SHEEO was founded by a group of five young people from poor, rural families who survived different acts of Human rights violations when they were growing up. After their studies, they decided to come together and initiate this organisation to fight for the integral well-being of the impoverished rural adolescents' girls and young women in Tanzania.

This organisation was founded on April 11, 2020 and was called first Awakening Horn for Inclusive Rural Development - AHIRD until February 13, 2024 whereby during the Annual General meeting of 2023 held on that date, the members decided collectively to change this organisation's name and become "Solidarity for Her Education and Empowerment Organisation – SHEEO" purposely to make the organisation focusing solely on rural adolescents' girls and young women due to its success in this area.

The new registration certificate number of this organisation is 00NGO/R/6939 enacted on June 7, 2024 by the NGOs Registrar of the United Republic of Tanzania.

VISION STATEMENT

Through its interventions, Solidarity for Her Education and Empowerment Organisation (SHEEO) wants to "ensure rural Tanzanian adolescents' girls and young women with their children thrive, become autonomous and lead their own development in an equitable society free from climate crisis."

MISSION STATEMENT

Solidarity for Her Education and Empowerment Organisation (SHEEO) has a sole mission and call which is "to empower rural adolescents' girls and young women with their children to fight poverty, illiteracy, climate change, gender-based violence and discrimination through education assistance and mentorship, socio-economic empowerment, theatre and sports initiatives, advocacy and capacity building on climate change, women's rights, sexual and reproductive health and rights".

2. PROGRAMMES OVERVIEW

Solidarity for Her Education and Empowerment Organisation (SHEEO) Programs have been designed to be the roadmap for achieving the organisation's mission, vision and objectives. The great strength in SHEEO programs designing and implementation is that it got the involvement of its beneficiaries in all steps and they are the one giving the organisation the best ideas and strategies/plans to make sustainable impacts through its interventions.

Solidarity for Her Education and Empowerment Organisation (SHEEO) Leadership, Staffs and Volunteers play a vital role of collecting, analyzing and putting into actions the ideas and strategies/plans suggested by the organisation's beneficiaries and bring them at the center of

implementation, monitoring and evaluation to make the organisation's actions to be "community-driven and owned" and the impact made to be "locally thoughtful and sustainable".

That is SHEEO approach to insure the communities it serves have power to think and decide on how they can overcome their problems/challenges and not planting in their hearts SHEEO's members and staff's own solutions just because of the expertise they have in addressing the problems/challenges the community faces.

Solidarity for Her Education and Empowerment Organisation (SHEEO) implements its activities under these six thematic/programs areas in rural areas of Tanzania:

- i) Quality Education, Technology and Innovation promotion for Girls;
- ii) Young-women Socio-economic Empowerment and Inclusion;
- iii) Gender-equality and Women's rights Advocacy;
- iv) Sexual and Reproductive Health and Rights and Bodily autonomy;
- v) Climate change and Environmental Protection;
- vi) Empowering Families for Equitable Parenting and Poverty Alleviation.

After its first registration in August, 2020, Solidarity for Her Education and Empowerment Organisation (SHEEO NGO) took some months for mobilizing resources and making necessary preparations before starting implementing its activities and reach its beneficiaries.

In January, 2021, Solidarity for Her Education and Empowerment Organisation (SHEEO) formerly known as Awakening Horn for Inclusive Rural Development – AHRID started its operations officially whereby in that year and due to big financial challenges, the organisation managed to reach and support 10 poor, rural families, 10 adolescents' girls studying in public and private primary and secondary schools and 10 impoverished young-mothers in Magu district.

In the year 2022, the scope of its activities increased and was able to help 38 impoverished, rural adolescents' girls to access education in two public secondary schools, 2 academically gifted neediest girls to access education at Kitenga Girls' Secondary School and empower 20 poor, rural young-mothers with vocational skills in Magu district.

3. PROGRAMMES ACHIEVEMENTS

The key achievements of Solidarity for Her Education and Empowerment Organisation (SHEEO)was through its four core projects implemented in the year ended December 31, 2023 in Magu district, Mwanza region in Tanzania as listed below:

Nurturing Talented Girls' Leaders of Tomorrow – NTGLT Project:

Project overall objective:

To support the rural, brilliant, neediest-orphaned and vulnerable girls to access education in reputable private secondary/open schools, public/private colleges and universities in Tanzania in order to prepare them to be leaders of tomorrow and change agents for both their lives and communities.

ii. Mwangaza Discovery and Learning Centre – MDLC Project:

Project overall objective:

To break the cycle of generational poverty to underprivileged, rural young-mothers aged between 15 to 30 years old by offering support and skills opportunities to enable them change both their livelihoods and children and become development actors in their communities.

iii. Supporting Her Education for Her Autonomy – SHEHA Project

Project Overall Objective:

To support the access and successful academic completion of secondary education for the most underprivileged rural girls to help them drive changes in their lives and communities using the power of education in Magu district, Mwanza region.

iv. Her Right to Decide for Her Future - HRDF Project

Project Overall Objective:

Empower 720 girls and boys in three public secondary schools and 90 key community stakeholders in three wards identified through organisation of capacity — building training-seminars, mentorship workshop and sensitization meetings to help them advocate, promote and advance girls' bodily autonomy and sexual and reproductive health and rights in order to create a safe community valuing and supporting girls' right to decide on their bodies, life and future in Magu district.

4. OUTCOMES FROM PROGRAMMES ACHIVEMENTS

As previously prescribed, the key achievements of Solidarity for Her Education and Empowerment Organisation (SHEEO) were experienced through its four core projects implemented in the year ended December 31, 2023.

i. Supporting Her Education for Her Autonomy - SHEHA Project:

This project reached 50 most poor, orphans and vulnerable adolescents' girls studying at Lumve, Bukandwe and Bujashi public secondary schools with sanitary pads for their menstrual hygiene, scholastic materials (school bags, school uniforms, stationeries), food, remedial classes and psycho-social counseling support whereby with the support offered, we witnessed the increase of those girls' enrollment and retention rates to school and improvements in their academic performances as well. All the 50 beneficiaries of this project were promoted to next level of their studies.

ii. Nurturing Talented Girls Leaders of Tomorrow N.T.G.L.T Project:

This Project helped 12 neediest brilliant girls to access their secondary education at 1 private school called Kitenga Girls' Secondary School based in Mara region, Tanzania and 2 Open Secondary Schools called The New Planet and Teachers Resource Centre both based at Kisesa Ward, Magu district, Mwanza region, Tanzania with tuition fees, sanitary pads and soap, scholastic materials (school uniforms, school bags, school shoes and stationeries) remedial classes and psycho-social counseling support. However, with this project activity, all the project beneficiaries were equipped with quality education and necessary skills which improved their academic performances and positioned them well to make their dreams happen after completing their studies.

iii. Her Right to Decide for Her Future-H.R.D.F Project:

The activities of this project took place at Bujora, Kisesa and Bukandwe wards, Sanjo division in Magu district, Mwanza Region in Tanzania by reaching 720 adolescents 'girls and boys at Lumve, Bukandwe and Kiswaga public secondary schools and 218 community development actors in these areas with knowledge and skills on adolescents' girls Sexual and Reproductive Health and Rights (SRHR) and bodily autonomy.

Through this project we strengthened leadership skills, self-esteem and power for poor, rural adolescents 'girls to decide on their bodies, lives and future.

iv. Mwangaza Discovery and Learning Centre-M.D.L.C Project:

This Project helped 20 abandoned and needlest vulnerable rural out of school adolescents 'girls and young mothers in Bujora and Kisesa wards, Magu district, Mwanza Region in Tanzania with vocational skills in tailoring and soap making. The beneficiaries after training benefited from the Project Implementation Team which accompanied Team which accompanied them for one year in their self-initiatives to liberate themselves from poverty with their children.

Accompaniment in their initiates to help them to create income-generating activities for their subsistence and to be economically self-reliant. This initiative enhanced economic opportunities and financial independence for reached poor, rural out of school adolescents' girls and young mothers as they initiated small businesses and manage them properly which ensured them to earn income for their needs and those of their children.

5. OBJECTIVE OF THE AUDIT

The objective of this engagement was to conduct a closeout audit of SHEEO NGO for the period from January 01, 2023 to December 31, 2023, in accordance with International Public Sector Accounting Standards (IPSAS) issued by the International Public Sector Accounting Standards Board (IPSASB). The specific objectives of the audit were to;

- Express an opinion on whether the schedule of expenditure of SHEO NGO presents fairly in all material respects in relation to its financial statements as a whole and in fund received, costs incurred, assets, commodities, and technical assistance directly procured with funding for the period audited in conformity with the terms of the award and generally accepted accounting principles;
- ii. Gathering and obtaining of evidence supporting the auditor's opinion on SHEEO NGO Fund.
- iii. Communicating findings by sharing of the results of audit to help users of the financial report to access the quality of the audit of SHEEO NGO.
- iv. Evaluate internal controls related to the SHEEO NGO Fund assess control risk and identify significant deficiencies including material weaknesses.
- v. Perform tests to determine whether SHEEO NGO complies, in all material respects, with agreement terms (including cost-sharing or matching contributions, and indirect costs rate, if applicable) and applicable laws and regulations related to SHEEO NGO Fund.
- vi. Evaluate whether SHEEO NGO has met its cost-sharing or matching contributions, if required by the agreement.
- vii. Determine if SHEEO NGO has taken adequate corrective action on prior audit report recommendations.
- viii. Gathering and obtaining of evidence supporting the auditor's opinion on SHEEO NGO Fund.
- ix. Drawing conclusions using all the available data of SHEEO NGO of whether the organisation's financial report is misinterpreting information.

6. AUDIT APPROACH/METHDOLOGY.

6.1 General

The audit work was carried out in the following distinct stages:

- Planning
 This included familiarization with the Programs activities, assessment and documentation.
- b. Execution We carried out detailed audit tests in accordance with International Public Sector Accounting Standards (IPSAS) issued by the International Public Sector Accounting Standards Board (IPSASB).
- Reporting
 We prepared a draft audit report that was submitted to the management of Solidarity for Her Education and Empowerment Organisation (SHEEO) Programs, for their comments.

6.2 Scope of the audit

We used the following steps as the basis for preparing the audit program. The procedures are in no way all – inclusive or restrictive. We have modified some procedure to fit local conditions and specific program design, implementation procedures, and agreement provisions for the Solidarity for Her Education and Empowerment Organisation (SHEEO) Programs.

6.2.1 AUDIT OF THE SCHEDULE OF EXPENDITURES OFSHEEO NGO FUNDS.

We examined the schedule of expenditures for the programs activities of Solidarity for Her Education and Empowerment Organisation (SHEEO) Tanzania for the period covered by the audit, and the costs reported by Solidarity for Her Education and Empowerment Organisation (SHEEO)as incurred during the period.

- The work carried out includes identifying and quantifying any questioned costs. Questioned costs were presented in the fund accountability statement in two separate categories i.e. ineligible costs and unsupported costs.
- Review of the general and Program ledgers to determine whether costs incurred were properly recorded. We reconciled direct costs billed to, and reimbursed by the Solidarity for Her Education and Empowerment Organisation (SHEEO) Program and general ledgers.
- 3) Review of the procedures used to control funds; including their channeling to contracted financial institutions. We also reviewed the monthly bank reconciliation statements and the controls on those bank accounts especially on approvals process for payments and coding of transactions in the respective cash books. We also obtained confirmation of bank balances as at December 31, 2023 for the Solidarity for Her Education and Empowerment Organisation (SHEEO) Programs.
- 4) Determine whether advances of funds were justified with documentation, including reconciliations of funds advanced, disbursed, and available. We also reviewed records and information to ensure that all funding received by Solidarity for Her Education and Empowerment Organisation (SHEEO) was appropriately recorded in Solidarity for Her

Education and Empowerment Organisation (SHEEO) accounting records and that those records were periodically reconciled.

 Review of the procurement procedures to determine whether sound commercial practices including competition were applied, reasonable prices were obtained and adequate control

were in place over the qualities and quantities received.

- 6) Review of direct salary charges to determine whether salary rates are reasonable for that position, in accordance with those approved by Solidarity for Her Education and Empowerment Organisation (SHEEO) is required and supported by appropriate payroll records. We determined whether overtime is charged to the Program and whether it is allowable under the terms of the agreements. Our procedures were also to enable us to determine whether allowances and fringe benefits received by employees were in accordance with the agreements, and applicable laws and regulations.
- Review of travel and transportation charges to determine whether they were adequately supported and approved.
- 8) Review of commodities (such as supplies, materials, vehicles, equipment, food products, tools, etc.) procured by Solidarity for Her Education and Empowerment Organisation (SHEEO) for Solidarity for Her Education and Empowerment Organisation (SHEEO) use. Moreover, we determined whether commodities exist or were used for their intended purposes in accordance with the terms of the agreements, and whether control procedures exist and have been placed in operation to adequately safeguard the commodities. Additionally, we performed end- use reviews on a sample basis to determine whether commodities exist or were used for their intended purposes in accordance with the terms of the agreements based on the control risk assessment.

6.3 INTERNAL CONTROLS

We reviewed and evaluated the Solidarity for Her Education and Empowerment Organisation (SHEEO) internal control's structure Programs to obtain a sufficient understanding of its design and determined whether they have been placed in operation.

The major internal controls components reviewed and evaluated included but not limited to the controls related to each revenue and expense account on the fund accountability statement.

Specifically, We;

- a) Obtained a sufficient understanding of the internal controls related to Solidarity for Her Education and Empowerment Organisation (SHEEO) Program and determined whether they have been placed in operation.
- b) Assessed inherent risk, control risk and determined the detection risk.
- c) Evaluated internal control established to ensure compliance with cost-sharing requirements including both provision and management of the contribution.
- d) Reviewed and evaluated other relevant policies and procedures pertaining to data used in application of audit procedures.
- e) Evaluated the control environment, the adequacy of the accounting systems, and control procedures. This evaluation included but not limited to the control systems for;
 - i. Ensuring that charges to the Program are proper and supported,
 - ii. Managing cash on hand and in bank accounts,
 - iii. Procuring goods and services,
 - iv. Managing inventory issue and receiving functions,
 - v. Managing personnel functions such as timekeeping, salaries and benefits,
 - vi. Managing and disposing of commodities purchased by Solidarity for Her Education and Empowerment Organisation (SHEEO).
 - vii. Ensuring compliance with agreement terms and applicable laws and regulations that collectively have a material impact on the Fund Accountability statement.







7. FUND ACCOUNTABILITY STATEMENT

7.1. FUNDS RECEIVED

Solidarity for Her Education and Empowerment Organisation (SHEEO) received a total of USD 2,500 from Annual contribution from Solidarity for Her Education and Empowerment Organisation (SHEEO) Founder and Ordinary Members, USD 20,000 from Grants and USD 6,255 from Donations made by Individuals and Companies for the period from January 01, 2023 to December 31, 2023.

For the period under review, January_01, 2023 to December 31, 2023, Solidarity for Her Education and Empowerment Organisation (SHEEO) received a total of USD 28,755. The funds received in cash were maintained in non-interest-bearing bank accounts. We validated 100% of the funds received by Solidarity for Her Education and Empowerment Organisation (SHEEO). The funds received were agreed to the program's bank statements and cash book.

7.2. EXPENDITURE

A total of USD 5,056.25 from Solidarity for Her Education and Empowerment Organisation (SHEEO) was spent for the Administrative activities and USD24, 305.00 from Solidarity for Her Education and Empowerment Organisation (SHEEO) was spent for Program Activities during the period from January01, 2023 to December 31, 2023. The selection of expenditure transactions for the detailed validation was based on our assessment of potential risk of misstatement. The selected sample transactions were validated in accordance with the procedures. We obtained evidence on the expenditure by testing to ascertain that all expenditure was appropriately supported and incurred for the Program as per Contract of Agreement.

NOTES TO THE FUND ACCOUNTABILITES STATEMENTS

Fixed Assets

Solidarity for Her Education and Empowerment Organisation (SHEEO) there are fixed asset budget for the whole project under review.

Fixed assets held at the year-end are recognized in the schedule of expenditures of all project's awards under review. All fixed asset with a useful life of more than one year are recorded and monitored through the fixed asset register.

Exchange rate

The currency payment is done in United States Dollar (USD) in accordance with the currency exchange at the time.
